PROJECT OBJECTIVES

- Mapping the current state of cooperation
- Create models of collaboration for all groups of fields of study
- Pilot testing of selected models
- Applying the principles of learning outcomes and their verification (ECVET)
- Quality assurance
- Draft legislative measures for strengthening the cooperation - legislation, funding, teaching methods

28 partnership being implemented

- 16 partnership in piloting
- 10 partnership in monitoring
- 2 without financial support
- 141 subjects involved
 - 38 schools, 99 companies, four other bodies
- 1,225 pupils involved

25 fields of study (in 3 categories; Upper Secondary Education with Apprenticeship Certificate, Upper Secondary with Maturita Exam, Supplementary Study leading to a Maturita Exam)

NEW MODEL OF VOCATIONAL EDUCATION

- Outcomes of a survey among secondary schools and companies has been published, includes examples of good practice as well as examples of barriers to mutual cooperation; 6 sub-reports form one comprehensive report
- Working Group is preparing a study for a new model of vocational education including proposals for necessary changes in 3 key areas:
 - LEGISLATIVE
 - FINANCIAL
 - TEACHING METHODS AND ORGANIZATION

EXAMPLES OF DRAFT MEASURES

- Accepting pupils to the joint preparatory first year (common for several study programmes in one field)
- „Stepped“ form of vocational education, ie. possibility for pupils at the end of the second (for 3-year programmes) and 3 (for 4-year programmes) to graduate with obtaining a vocational qualification
- Extension of the stay of students in training, practice expansion in the second half of the 3rd year in fields of education with an apprenticeship certificate
- Supplement to the school educational programmes on cooperation between schools and companies
